### Word from the chair

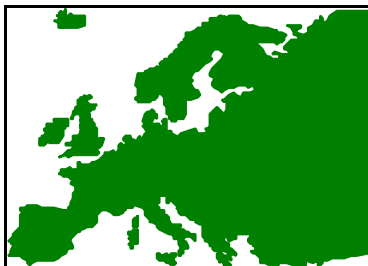

#### Voting procedure

As described in the constitution voting is per national DURG, i.e. one country one vote. Every country will empower a representative to vote. Members are reminded to notify the nominating committee in time about the name of the representative (Prof. dr. Annemarie Hoffmann, fax +49 3641 937788; email: ahoffmann@landgraf.med.uni-jena.de). Individual members will appoint their representative at the meeting; if enough members are present per country, different country groups can be formed. Needless to say that candidates for the executive committee cannot act as representative from that country for voting.

The voting will be for a chair, and separately for 10 members who will then divide the different functions (vice chair, secretariat, treasurer) among themselves. Candidates for the post of chair are not yet known. The chairs of the national DURGs will be notified about this issue as soon as possible.

The election shall be by secret ballot. Decisions are taken by simple majority vote.

## Information on the working groups

### Mapping Europe

*Coordinator: R Vander Stichele*

First, work in progress will be presented as a report on the meetings with WHO-Europe, WHO-CC Drug Statistics Methodology, and the European Commission DG III.

Marit Rønning and Robert Vander Stichele will be rapporteur of past activities, in the presence of Kees de Jonckheere, regional advisor for Pharmaceuticals, WHO-Europe.

A draft survey on the status of national drug classification systems and data utilization collection systems will be presented.

The strategy will be discussed for submitting the questionnaire in the different countries, for establishing contact between the competent authorities and the scientific community

A draft of memorandum of the scientific community to the competent authorities, on the subject of the adoption of quality standards in drug utilization review systems.

A draft of standards in drug classification will be presented, and submitted to discussion.

The work of the Centre Europeen de Normalisation on the subject will be presented.

A list of contact-persons per country needs to be established (with the possibility of a 1/8 full time equivalent funding per country).

Preparations need to be made for a European symposium on standards in drug classification, gathering the DURG scientific community and the competent authorities of 20 European countries, Israel and Canada, in early 1999.

### Workshop on confidentiality: balancing personal rights and processing of health data

The workshop will pursue the activities of former workshops on confidentiality of EURO DURG. The European Directive (95/46 EG-ED) on Confidentiality allows the processing of health data only if

1. the specified goals of research are of public interest and cannot be achieved in any other way.
2. the processing of health data is observing special rules for conduct protecting privacy.

Certified researchers have to become authorized not being compelled in any proceedings to identify individuals who are subject of health research ("Confidentiality of research").

To strengthen the position of national DURGers, the workshop will discuss these preconditions and propose a resolution which names specified goals of research of public interest and defines the responsibilities of independent review boards, that will approve the design of research projects using personal health data and their rules of conduct respecting the privacy of patients for certification.

Referees from different European countries will give examples of DUR for supporting public health concerning adverse drug reactions, quality of prescribing or cost containment.

With respect to the promotion of protecting privacy they will refer to the questions

- do already exist independent review boards approving research projects for certification, how are they composed and what are their responsibilities?
- are national DURGs already formulating principles guiding the conduct for drug utilization research using personal health data?

### The user perspective in drug utilisation research

*Background.* Participants at the 1<sup>st</sup> Congress of the European Drug Utilisation Research Group in 1996 at Lake Balaton showed great interest in researching the user perspective on medicine. It was decided to conduct workshops on the User Perspective Project (TUPP) during the EURO DURG Conference in Berlin 1997. The workshop concluded that a project should be developed, with a special focus on antidepressants and tranquillisers. Several EURO DURGers declared their interest as project participants.

The project has been further developed with support from WHO EURO Pharmaceutical Unit.

The *objective* of the Berlin workshop 1998 is to further develop the user perspective in European drug utilisation research.

*Contents.* the workshop will discuss the following topics:

- What do we know already? A summary of previous work on the user perspective (Nicky Britten, London)
- Protocol for a European study - TUPP The User Perspective Project (Ebba Holme Hansen & Anna Birna Almarsdóttir, Copenhagen)
- Strategies for further EURO DURG research re. the user perspective (group discussion and recommendations)

### Improving the quality of drug use

*Coordinator dr. I Shubert*

Improving rational prescribing is high on the agenda in many countries. Different strategies have been developed but, in particular in Europe, scientific evaluation of their effects is still often lacking. From the evidence so far no general conclusions can be made regarding the effectiveness of different strategies. In the working group meeting in Berlin 1997, the discussion focused on criteria to assess rational prescribing (Eur J Clin Pharmacol 1998;54:113-8, Drug utilization 90% - a simple method for assessing the quality of drug prescribing). This year attention is paid to educational tools and programmes and the implementation of programmes county wide or nation wide.

The *objective* of the meeting in 1998 is to exchange experiences with different approaches and with implementation as well as to formulate the way ahead in drug utilization research regarding evaluation of intervention strategies as well as implementation issues. *Contents:* the workshop will discuss the following topics
